*** With the exception of: (repairs to) removable dentures (worn as implants) (complete dental prostheses for the upper and/or lower jaw); missed appointments; orthodontics; implantology.

**** Treatments only qualify for reimbursement if carried out by a care provider listed in the insurance conditions. For reimbursement of care by another care provider, you can submit a written request to the HollandZorg medical advisor.
